English version of the original minutes

'Shrihari'

A meeting of 'Anandilal Vidya Prachar Sanstha' was held at the place of Pujya Mahatma Gandhiji (Labournam Road, Bombay) on Miti-Shravan Krishna 15, Samvat 1978, that is on August 2, 1922. The names of the Trustees present :

Mahatma Gandhiji Pandit Madan Mohanji Malviya Seth Anandilalji Podar Seth Jamnalalji Bajaj

1. It was decided that the institution be named 'Shekhawati Brahmcharya Ashram' and the Trust be named 'Anandilal Vidya Prachar Sanstha', (Anandilal Eduction Society).

2. It was decided that the capital of Rs. 2,01,000 (Two lac one thousand), given by Shriyut Anandilalji for the development of education in Shekhawati and neighbouring region, be withdrawn from Tilak Swaraj Fund and deposited with the capital of 'Anandilal Vidya Prachar Sanstha' in the name of the aforementioned four trustees.

3. It was decided that the capital be deposited in the name of the four trustees in whichever bank Shriyut Anandilalji and Jamnalalji found it appropriate.

4. It was decided that money could be withdrawn from the bank through the signatures of these two gentlemen : Jamnalalji Bajaj and Anandilalji Podar.

5. It was decided that Shriyut Maganlalji Gandhi at Ahmedabad be written to prepare a scheme for studies.

6. It was decided that a Head Master be kept at Rs. 150 (Rs. One Hundred fifty) per month.

7. It was decided that in the event of inconvenience in organising meeting, the functioning be carried out by obtaining suggestions from the trustees by post.

8. It was decided that Mahatma Gandhiji would be the Chairman of this Institution.

Trust and Social Commitment

The saga of the Podar Family's

social commitment begins with the active life of Shri Anandilal Podar. He was a great humanist, philanthropist and a commercial magnate wedded to the social commitment. His vision was foresighted enough to serve the society by creating and nurturing institutions of learning, health care, worship, sports, recreation etc.

In 1921, Mahatma Gandhi, Father of the Nation, gave a call to the nation for a donation, amounting to Rs. 1 crore under the banner of 'Tilak Swaraj Fund'. He announced that if the fund was not collected in a given time, he would relinquish politics and go to the Himalayas. Due to oppressive British Raj, people were afraid of donating and be in the limelight. Less than 20 days remained to the last date and insignificant money was collected. Shri Motilal Nehru, Pandit Madan Mohan Malviya, Shri Jamnalal Bajaj and the other leaders were full of anxiety. They well knew of the resolve of Mahatma Gandhi but had no solution in sight. They could collect the money but wanted someone to take the lead. Shri Jamnalal Bajaj thought that he could probably approach his friend, a middle level but very bold, noble

hearted businessman, to take the initiative in the interest of the nation. He approached Shri Anandilal who readily agreed to give a donation of Rs. 2,01,000/- to 'Tilak Swaraj Fund'.

Shri Anandilal, requested Shri Jamnalal Bajaj and Pandit Madan Mohan Malviya if his contribution could be utilised for education in his home town, Nawalgarh, and if a Trust could be formed with Mahatma Gandhi as the Chairman Trustee and Pandit Madan Mohan Malviya, Shri Jamnalal Bajaj and he himself as the founder Trustees. Mahatma Gandhi agreed. The same year, The Anandilal Education Society was formed with the above four Trustees. As visualised, the fund was collected in time.

Moving with times and activities undertaken, the Society's name was changed to The Anandilal Podar Charitable Society in 1936 and then to The Anandilal Podar Trust in 1999.

In 1921, Mahatma Gandhi, Father of the Nation, gave a call to the nation for a donation, amounting to Rs. 1 crore under the banner of 'Tilak Swaraj Fund'.



In 1930, owing to their political pre-occupation, Mahatma Gandhi and Shri Jamnalal Bajaj retired from the Trusteeship of the Society.

Shri Madan Mohan Malviya, the Founder Trustee and the most renowned scholar of that time became the Chairman of the Society till his demise in 1946.

Thereafter, two sons of Shri Anandilal chaired the Trust and guided its activities - viz. Raja Ramdeo from 1946 to 1952, and Dr. Ramnath from 1952 to 1989. Since then i.e. 1989 Shri Kantikumar, grandson of Shri Anandilal and son of Dr. Ramnath heads the Trust.

To begin with, the Society/Trust established a 'Shekhawati Brahmacharya Ashram' (School) in 1922 at Nawalgarh, in the State of Jaipur, now part of Rajasthan. The same was elevated to a High School (1930) and subsequently to Intermediate College (1942) and to Post Graduate College (1947). It was inaugurated by the Prime Minister of Jaipur State, Sir Mirza Ismail. This college had the distinction of being the first College in the State of Jaipur. It was started prior to Rajasthan University and had to be affiliated to Agra University in the State of Uttar Pradesh.

To give concrete shape to the noble ideals, the Podar family established various institutions/establishments, almost all bearing the names of Podar.

Today they number almost 50 institutions. They comprise of Schools, Colleges, Management Institutes, Teachers Education and Vocational Training Centres, Labour Recreation Centre, Ayurvedic Hospital with 310 beds. Ayurvedic College, Ayurvedic (Medical) Research Centre, Dumb and Deaf School, Sports Complex, Temples, Museum, Cultural Centre, Conference Halls, Hostels, Recreation Park etc.

Nawalgarh being the first Social Commitment of Podars and The Anandilal Podar Trust being located there, a special reference about it is given below:

All establishments at Nawalgarh are being run by The Anandilal Podar Trust.

Nawalgarh, a small town of approximately 70,000 persons (Year 2005) is amongst the most progressive Education Complex in Rajasthan. The College has very competent Professors and To begin with, the Society/Trust established a 'Shekhawati Brahmacharya Ashram' (School) in 1922 at Nawalgarh the State of Jaipur, now part of Rajasthan.





Teachers. In Keeping pace with modern system of teaching, a huge well staffed air-conditioned Computer Centre is functioning. Computer education is made compulsory from Primary School to College. The College also has the third biggest library in the State. Internet facility is provided to all Professors and Students.

Even in Science and Management, it has post graduate classes in diverse subjects such as Botany, Zoology, Chemistry, Environmental Science, Biotechnology, Information Technology, Pharmaceutical Chemistry, P.G. Diploma in Marketing Management, Human Resources Management, Computer Application, Computer Accounting and Audit etc. It is for these reasons that the College is amongst the top institutions in Rajasthan. Year 2006 will see addition of such diverse professional subject as Advance Diploma in Retail Management, Travels & Tourism, Insurance & Risk Management and current hot subject – Animation.

The Trust established an Institute for Career Development. The Institute takes care of the overall personality development, fluency in English and Special training for specific needs of the Industry. The Institute is in regular touch with over 100 Industrial establishments to get its M.S. students in particular, trained in Industry and also get them employment.



Nawalgarh, a small town of approximately 100,000 persons (Year 2012-13) is amongst the most progressive Education Complex in Rajasthan. In Sports, Podar Sports Club has excelled in Cricket. Number of its students have been in the University team. In Football, it has won Inter Collegiate Tournament in the years 2000, 2002, 2003 and 2014 in Athletics (20 km. Walk) in 2003 and was runner up in Volleyball in the years 2000, 2003 and 2005. In individual events, the College won in Wrestling in 1999 and 2004, Boxing (48 kgs) in 2000, Boxing Open weight in 2001, Javellin throw in 2002, Judo (84 kgs) in 2004. The College won the Rajasthan University Inter Collegiate Handball Tournament, 2005–06. In the same year College won Rajputana Cup in the Rajasthan University Inter Collegiate Athletics Meet.

Paintings, Craftmanship, Debating, Chess, Badminton, Table-tennis, Volleyball, Basketball, Swimming and more are also being encouraged.

The NSS volunteers of the College, who represented the entire Rajasthan, won the award for the best participation at the National Integration Camp (2005) sponsored by the Ministry of Youth Affairs & Sports, Government of India held at Srinagar in Uttaranchal.





Social tributes to Podars

In recognition of the contributions of Shri Anandilal to the community and at the suggestion of Shri Vallabhbhai Patel; citizens of Bombay installed a 7 feet statue at one of the most prestigious and prominent place in the heart of Bombay - the Hanging Gardens, the only statue of a Rajasthani in Mumbai till today. (1947)






